
KAFEA TERRA'S CODE OF CONDUCT FOR SUPPLIERS


HUMAN RIGHTS

Suppliers should comply with all applicable data protection laws and nondisclosure any business, economic, technical or other form of information, occurs from the relationship with KAFEA TERRA.


BRIBERY
